The Features and Flaws of Post-Postmodern Medicine 01 2023 – Present

Today, the shape and practice of American medicine have transformed in many ways, occurring in an era marked by “warp speed” innovation and increased patient advocacy alongside growing disparities and “infodemics.” The social, technological, and political changes of the new millennium that have created this post-postmodern environment, however, stem from advances made possible by modern science as well as promises of greater subjectivity and inclusiveness under postmodernism. Today, another social refashioning of medicine seems afoot—its beginning marked by developments such as the 1997 FDA rule change allowing direct-to-consumer advertising (DTCA) and the 2003 completion of the Human Genome Project. Interestingly, the new post-postmodern medicine, within a larger context influenced by the Internet and social media, possesses hallmarks of a premodern system: dominated more by the care and beliefs of individuals and families, health knowledge gained through informal channels and word of mouth, and a relatively crowded-but-downgraded medical marketplace where different schools of practice abound. Like recent U.S. Supreme Court cases grounded in originalist approaches, modern American medicine seems to have, if not returned to earlier times, revived old perspectives in current practice.

The Conditional Cogito of Coleridge’s “Kubla Khan” 11 2022 – Present

In the crafting of “Kubla Khan,” Samuel Taylor Coleridge tells us that his now-famous but (professedly) unfinished poem arose from an opium dream in which “the Author” played very little part. In distancing himself as the creator and even removing his *self* from the act of thought and examination, upon awaking Coleridge becomes but a tool used to capture the fictional, internal events that somehow become things external to him. The entire story is conditional, and all Coleridge has is “a distant recollection of the whole,” rather than the individualized authorial self that has come to dominate modern philosophy and literature. An “I” emerges only in the third (and final) strophe of the poem, almost as an afterthought. Without a thinking self or even things a “mind [...] so clearly and distinctly” can examine, “Kubla Khan” turns C. K. Ogden and I. A. Richards’ semantic triangle inside out, even collapses it, so that, in the end, all that truly exists—and perhaps the only place we can find the self—are the (fictional) signifiers that survive beyond us.

‘Anatomy Park’ and Converting the Body for Fun 06 2021 – 08 2023

Book chapter (under consideration for an edited volume on the anthropology of the body) critiquing the means through which bodies have been colonized for pleasure or spectacle in science and history and examining how this might apply today: for example, in the edutainment of *BodyWorlds*; issues of consent and consequences of OnlyFans; or the NFL’s disregard of injuries or players who kneel for fear of “ruining the fun of the game.” These examples and others highlight a modern-day colonialism in converting bodies (as well as the body politic) for fun.

Biorobots and the Devolution of Personhood 04 2022 – 03 2023

A recurrent theme in science fiction involves “AI uprisings,” often in the guise of anthropomorphic robots created to serve humanity but who outgrow our intentions and begin to demand moral and legal equivalence. The idea can be traced to Karel Čapek’s *R.U.R.* and has been dramatized in many films and TV



series since. Whether and when robots are persons are at the heart of these stories, and when it comes to personhood, substance and origin do not matter. Rather, it is the possession of attributes like consciousness, the capacity to reason and communicate, self-awareness, and being accountable for one's actions. Interestingly, the *Star Wars* universe poses the opposite question: whether it is morally acceptable to treat cloned soldiers as less than persons. Using a "reverse ethics" analysis of Čapek's play, storylines from *Star Wars* spinoffs, and Mary Anne Warren's discussion of "characteristics [that] entitle an entity to be considered a person," this paper explores modern examples of "biorobotism" (such as the use of Kenyan workers to train OpenAI; hospital staffing during the COVID pandemic) and the precipitating conditions and consequences of "biorobotic" othering.

Ideally, informed consent is achieved through (ongoing) conversation between a health care provider and a patient regarding the patient's care, where both parties reach a level of shared understanding. How can providers ensure and improve communicative action, and do certain laws and the health care system itself impede emancipatory understanding and, thus, patient autonomy?

'Men Against Fire' and the Propagation of Propaganda

11 2019 – 04 2020

Book chapter examining the ethics and inevitability of propaganda using the *Black Mirror* episode "Men Against Fire," Edward Bernays' treatise *Propaganda*, and S. L. A. Marshall's book *Men Against Fire: The Problem of Battle Command*. What is propaganda? Is it always immoral? And what examples of propaganda exist today, particularly with regard to the Trump administration and public health.

'The Orville,' Pop Culture, and Lacan

08 2019 – 12 2019

Book chapter for the edited volume *Exploring The Orville* examining the comedy-drama sci-fi program and creator Seth MacFarlane's use of pop-cultural references through the work of French psychoanalyst Jacques Lacan and his notions of the "mirror stage," the "ideal ego," and the "ego-ideal." In several episodes, these references and, thus, the television series itself act a mirror that enables both the characters of the show and, through them, the viewers to simultaneously see ourselves in the "other" and in doing so recognize the fragmentations of our own selves. Lacan, however, takes this one step further: As we introject these external images, particularly those from an ideal perspective, the ego-ideal is formed—which modifies the ego, inverts our sense of self and forces us to question it, and by turning to moralistic goals betters our own subjectivity.

Allegories of Plato, Aristotle, and Naguib Mahfouz

10 2015 – 03 2019

Engaged in a philosophical analysis of Naguib Mahfouz's Nobel Prize-winning *The Cairo Trilogy*, using Plato's allegory of the cave and Aristotle's *Nicomachean Ethics* to explore the saga of this fictional twentieth-century Egyptian family.

'Black Mirror,' Eugenics, and Othering Outside of War

06 2017 – 08 2018

Analyzed "Men Against Fire," an episode of the U.K. anthology series *Black Mirror*, examining S.L.A. Marshall's controversial 1947 book *Men Against Fire: The Problem of Battle Command*, the bureaucratization of dehumanization outside of war, and eugenics and Jim Crow policies of the twentieth century. A peer-reviewed paper has been published in volume 23 of *Film and Philosophy*.

To borrow metaphors used by leading advocates on both sides of the ECT debate, proponents have viewed ECT as something akin to a "penicillin of psychiatry," while opponents have compared it to industries like Big Tobacco. These types of metaphors often are employed when answering ECT's two primary questions: Does it work, and does it irrevocably impair memory?

Presentations: PCA/ACA, ASU Women's Empowerment Month Analyzed the television series *Hannibal*, examining how the creators attempted to engage in "gender-bending." In this latest installment of the "Hannibal" franchise, which began with Thomas Harris' novel *Red Dragon*, the small but essential role of Dr. Alan Bloom is transformed into "Alana." In the novel, Bloom is preceded by his reputation, known for being not just "a good forensic psychiatrist" but "maybe the best," as well as his moral engagement with others. The gender transformation in the television program, however, undermines the Bloom character: Depicted as superficial in her emotions and moral distress and as lacking reason, Alana is used as a force to further the aesthetic violence and allowed to be neither "hero" nor "anti-hero." This research was presented as part of Armstrong's Women's Empowerment Month and at the PCA/ACA conference in Seattle in March 2016.

Presentations: InterProfessional Health Care Summit Analyzed mandatory disease reporting to examine whether public health needs associated with epidemiological surveillance, health promotion, and public health planning are effectively achieved and whether the advantages of reporting outweigh privacy, autonomy, and the potential risks of discouraging individuals from seeking testing and care. Despite an increase in the number and ease of STI testing methods, it is unclear whether individuals understand the importance and implications of being tested. Regarding the reporting process, inconsistencies exist in the knowledge and training of health workers; informed consent may not occur before testing is performed; and the promise of confidentiality may be a myth.

By exploring empathy's role in scientific discovery and knowledge, *Hannibal* examines cultural fears of the fuzzy postmodern constructions of science and the self and suggests that, rather than undermining understandings of the world or ourselves, an empathetic approach to discovery is more authentic and ethical because it leads to both greater recognition of oneself and others and who we are in relation with others (identity as co-constructed) as well as greater capacity to take responsibility for our actions. This paper was presented at the 4th annual Health Humanities Conference at Western Michigan University in September 2014 and at the Popular Culture Association/American Culture Association annual conference in April 2015. A peer-reviewed paper was published in volume 20 of *Film and Philosophy* in 2016.

HIV/AIDS Among Brazil's Prison Populations

01 2012 – 12 2012

Using Brazil as a case study, examined the political, public health, and human rights implications for failing to provide detainees and prisoners with adequate safety and health care, particularly with regard to infectious diseases such as HIV and AIDS. Advocated for the dual ethical obligation to earmark resources, even when scarce, toward the study and care of prisoners and, at the same time, to protect this population during surveillance and treatment, especially with regard to infectious diseases associated with stigmatized or illegal behaviors. Findings suggest that both failing to advocate for the incarcerated as well as advocating in a poorly considered way are cause for concern. Additionally, misleading metaphors surrounding prisons and penal systems and the marginalization of prisoners and certain socioeconomic classes lead to a perpetuation of diseases like HIV and AIDS. Brazil provides a telling example, despite having innovative programs and a Constitution that frames health care as a right of all. This paper was presented at the 16th annual Conference on the Americas in February 2013 and peer-reviewed paper was published in the *Journal of Infectious Diseases and Therapy* in 2014.

Heidegger and 'House': Tasks of American Medicine

Conducted Grounded Theory research with a colleague from Armstrong State University's Department of Languages, Literature, and Philosophy exploring all six seasons of "House M.D." in relation to both Martin Heidegger's phenomenological conceptions of truth and Being (from his 1927 masterpiece, *Sein und Zeit [Being and Time]*) and the discourse of the current health care reform debate in the United States. Following Heidegger's suggestion that metaphor may clarify Being, findings suggest that the television program not only depicts and illuminates central themes in 20th-century phenomenology, but, in doing so, may be instructive for understanding distinct problems in health care and public health today.
